AN ORDINANCE CHANGING THE ZONING MAP OF JEFFERSON COUNTY

WHEREAS, the Board of Commissioners of Jefferson County is advised that the Jefferson County Plan Commission has held a public hearing, following the giving of required notice, on proposed zoning map change, and

WHEREAS, said Commission has given a favorable recommendation for the zoning map change, and

WHEREAS, this Board concurs in the recommendation of said Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF JEFFERSON COUNTY, STATE OF INDIANA:

That the Jefferson County Zoning Map shall be changed, to wit:

The 221.086 acers of property located at 101+ W. JPG Ordinance Drive, JPG Proving Ground, parcel numbers 39-03-34-000-001.001-010, 39-03-35-000-005.001-010, 39-08-03-000-001.001-006, 39-08-02-000-002.001-006 to be rezoned from dual zoning of R-1 and AG (residential and agricultural) to AG (agricultural).




